of plain bearings at the aft section of tail rotor transmission installed on AS 350 B, B1, B2 and D helicopters.

Subsequent to some reports of in-service failure of the tail rotor shaft section bearings, which could lead to a loss of the tail rotor drive, and in order to preclude further failures, the following measures are rendered mandatory.

#### 1. CHECKS

Within the next 50 flying hours after the effective date of this Airworthiness Directive for non-regreasable bearings only, if this has not already been done, check that the bearings are square with the shaft and check the condition of the bearings and of the mountings as per paragraph 1C(1) and 1C(2) of referenced AS 350 SB n° 05.08 R4.

For all types of bearings (regreasable and non-regreasable alike):

- The visual checks as per paragraph 1C(2)(b) of referenced Service Bulletin must be performed (without removal) every 100 operating hours.

#### 3. OPERATING LIMIT

Non regreasable bearings SKF P/N 6007.2RS 1 MT 47CA, AS P/N 704A33.651.010 have a service-life of 1 200 hours.
