Rudder servo-control desynchronization

This Airworthiness Directive applies to AIRBUS INDUSTRIE A300, A310 and A300-600 aircraft, all certified models and all serial numbers.

In order to detect and prevent rudder servo-control desynchronization, which could:

- lead to structural fatigue due to opposing forces,
- affect the aircraft handling quality, if desynchronization is combined with an engine failure and the loss of the related hydraulic system,

the following measures are rendered mandatory from the effective date of this Airworthiness Directive.

- 1- Within 500 flight hours following November 02, 1996, or before accumulation of 1,300 flight hours, whichever occurs later, check the synchronization of the rudder servo-controls in accordance with the instructions of AIRBUS INDUSTRIE Service Bulletins A300-27-188 Rev. 2, A310-27-2082 Rev. 2 and A300-27-6036 Rev. 2. Depending on the findings of the previous check, perform a structural inspection in accordance with the instructions of AIRBUS INDUSTRIE Service Bulletins A300-55-044, A310-55-2026 and A300-55-6023.
- 2- Repeat the desynchronization check every 1,300 flight hours (if necessary, repeat the structural inspections in accordance with the intervals specified in AIRBUS INDUSTRIE Service Bulletins A300-55-044, A310-55-2026 and A300-55-6023).
