A310 and A300-600 Aircraft

N1 (or EPR) limit setting on TRP (thrust rating panel)

This Airworthiness Directive applies to AIRBUS INDUSTRIE A310 and A300-600 aircraft, all certified models and all serial numbers on which the following AIRBUS INDUSTRIE modifications have not been embodied:

- N° 7174 or 7588 or 8246 (AIRBUS INDUSTRIE Service Bulletins A310-22-2031, A300-22-6017, A310-22-2025, A300-22-6010 or A310-22-2035) for aircraft equipped with GENERAL ELECTRIC CF6-80C2 engines.
- N° 7694 (AIRBUS INDUSTRIE Service Bulletins A310-22-2027 or A300-22-6011) for aircraft equipped with PRATT & WHITNEY PW 4000 engines.

In order to detect and prevent the TCC (Thrust Control Computer) sensitivity to any transient thrust loss, which affects the values of the N1 Limit/Target or EPR Limit/Target parameters calculated by the TCC during the initial setting for take off, the following measures are rendered mandatory from the effective date of this Airworthiness Directive:

- 1. Introduce the following temporary Revisions into the Aircraft Flight Manual (AFM):
 - Temporary Revision 4.03.00/18 for A300-600 with PW 4000 engines
 - Temporary Revision 4.03.00/19 for A300-600 with GE CF6-80C2 engines
 - Temporary Revision 4.03.00/20 for A310 with GE CF6-80C2 engines
 - Temporary Revision 4.03.00/21 for A310 with PW 4000 engines

and apply the corresponding procedures.
