Alternate braking system check (ATA 32)

APPLICABILITY:

All model A330 series aircraft, certified in any category on which AIRBUS INDUSTRIE 47210 modification or AIRBUS INDUSTRIE A330-32-3086 R1 Service Bulletin has not been embodied.

REASON:

This Airworthiness Directive is prompted by a recent event of an alternate braking system loss leading an A320 aircraft to go beyond the end of the runway at landing. This event was due to the freezing in flight of water ingressed in the bottom of the Braking Dual Distribution Valve (BDDV) preventing the alternate braking mode to operate at landing.

Revision 3 introduces an Alternate Means of Compliance (AMOC) which cancels the repetitive operational in-flight checks.

This Revision 4 takes into account AIRBUS INDUSTRIE 47210 modification

MANDATORY ACTION AND COMPLIANCE DATES:

In order to detect a possible loss of the alternate braking system resulting from a possible in flight seizure of a BDDV due to water freezing, the functional test and, when necessary, the associated maintenance tasks described in Paragraph 4 of AIRBUS INDUSTRIE A.O.T. 32-19 revision 2 dated August 20, 1998 must be applied and the results must be reported to AIRBUS INDUSTRIE.

ALTERNATE SOLUTION:

October 06, 1999

The modification of the BDDV in accordance with instructions given in AIRBUS INDUSTRIE Service Bulletin A330-32-3086 R1 constitutes an alternative means of compliance of the hereabove mentioned mandatory actions.

Note 1: Embodiement of this modification introduces maintenance action 324314-01-1 at 4A interval.
