# **BRAZILIAN AIRWORTHINESS DIRECTIVE**

#### AD No.: 2012-10-02

#### Effective Date: 29 Oct. 2012

The following Brazilian Airworthiness Directive (AD), issued by the Agência Nacional de Aviação Civil (ANAC) in accordance with provisions of Chapter IV, Title III of Código Brasileiro de Aeronáutica - Law No. 7,565 dated 19 December 1986 - and Regulamento Brasileiro da Aviação Civil (RBAC) 39, applies to all aircraft registered in the Registro Aeronáutico Brasileiro. No person may operate an aircraft to which this AD applies, unless it has previously complied with the requirements established herein.

## **APPLICABILITY:**

This Airworthiness Directive (AD) applies to Embraer SA model ERJ 190-100 STD, ERJ 190-100 LR, ERJ 190-100 IGW, ERJ 190-100 SR, ERJ 190-200 STD, ERJ 190-200 IGW airplanes; all serial numbers.

**Note 1:** This AD requires revisions to certain operator maintenance documents to include new inspections tasks or modification of existing ones and its respective thresholds and intervals. Compliance with these inspections is required by "Regulamento Brasileiro de Homologação Aeronáutica" - RBHA 91.403(c). For airplanes that have been previously modified, altered, or repaired in the areas addressed by these inspections, the operator may not be able to accomplish the described inspections. In this situation, to comply with RBHA 91.403(c), the operator must request approval for an alternative method of compliance. The request should include a description of changes to the required inspections that will ensure the continued operational safety of the airplane. An alternative method of compliance or adjustment of the compliance time that provides an acceptable level of safety may be used if approved by the Manager, Product Certification Branch (GGCP).

# **CANCELLATION / REVISION:**

This AD cancels and supersedes AD 2011-05-04 / 39-1339, dated June 16<sup>th</sup>, 2011, and is being issued to include additional actions.

# **REASON:**

This AD results from a new revision to the Airworthiness Limitations Section (ALS) of Embraer ERJ 190 Maintenance Review Board Report (MRBR 1928), to include new or modification of the current tasks and its respective thresholds and intervals. Failure to inspect these structural components, according to the new or revised tasks, thresholds and intervals, could prevent a timely detection of fatigue cracking. These cracks, if not properly addressed, could adversely affect the structural integrity of the airplane.

## **REQUIRED ACTION:**

Revision of the Maintenance Program to include Airworthiness Limitations Inspections updates.

# **COMPLIANCE:**

Required as indicated below, unless already accomplished.

(a) Within 60 days after the effective date of this AD, revise the Maintenance Plan for the Embraer ERJ 190 aircraft to include Airworthiness Limitations Inspections updates, as described on Maintenance Review Board Report (MRB-1928) revision 06, dated August 20<sup>th</sup>,2012, or further revision approved by ANAC, observing for each task, the pre and post-mod condition of the associated service bulletin.

## Alternative Method of Compliance (AMOC)

(b) A different method or a different compliance time, with requirements of this AD, may be used if approved by the General Manager of the Aeronautical Product Certification Branch (Gerência-Geral de Certificação de Produtos Aeronáuticos (GGCP)).

Record compliance with this AD in the applicable maintenance log book
