Landing Gear - Nose Landing Gear - Nose Wheel Steering Selector Valve Slow to Deactivate

Applicability:

Bombardier Inc. model BD-100-1A10 aeroplanes, serial numbers 20003 through 20892.

Compliance:

Background:

The nose wheel steering selector valve (SSV) can be slow to deactivate under low temperature conditions. A slow SSV deactivation in combination with an un-commanded steering input could lead to a delayed transition to free castor mode and result in an aircraft runway excursion.

This AD mandates the replacement of the affected SSV part number (P/N) 41130-107 with the re-designed SSV P/N 41130-111.

Corrective Actions:

Part I - Installation and Testing of new SSV P/N 41130-111

- A. Within 36 months from the effective date of this AD, replace the SSV P/N 41130-107 with the new SSV P/N 41130-111 in accordance with Paragraph 2.B. of the Accomplishment Instructions of the applicable Bombardier Inc. Service Bulletin (SB) listed in Table 1 below, or later revisions approved by the Chief, Continuing Airworthiness, Transport Canada.
- B. Following the installation of the new SSV P/N 41130-111, perform the testing required by Paragraph 2.C. of the Accomplishment Instructions of the applicable Bombardier Inc. SB listed in Table 1 below, or later revisions approved by the Chief, Continuing Airworthiness, Transport Canada.
