



## Airworthiness Directive

**AD No.: 2024-0019**

**Issued: 11 January 2024**

Note: This Airworthiness Directive (AD) is issued by EASA, acting in accordance with Regulation (EU) 2018/1139 on behalf of the European Union, its Member States and of the European third countries that participate in the activities of EASA under Article 129 of that Regulation.

This AD is issued in accordance with Regulation (EU) 748/2012, Part 21.A.3B. In accordance with Regulation (EU) 1321/2014 Annex I Part M.A.301, or Annex Vb Part ML.A.301, as applicable, the continuing airworthiness of an aircraft shall be ensured by accomplishing any applicable ADs. Consequently, no person may operate an aircraft to which an AD applies, except in accordance with the requirements of that AD, unless otherwise specified by the Agency [Regulation (EU) 1321/2014 Annex I Part M.A.303, or Annex Vb Part ML.A.303, as applicable] or agreed with the Authority of the State of Registry [Regulation (EU) 2018/1139, Article 71 exemption].

## ATA 05 – Time Limits / Maintenance Checks – Airworthiness Limitations Section – Amendment

### Manufacturer(s):

SAFRAN Helicopter Engines, S.A. (SAFRAN), formerly Turboméca, S.A., Rolls-Royce Turboméca

### Applicability:

RTM 322-01/9 and RTM 322-01/9A engines, all serial numbers.

These engines are known to be installed on, but not limited to, NH Industries NH90 (military) helicopters.

### Definitions:

For the purpose of this AD, the following definitions apply:

**The ALS:** The Airworthiness Limitations Section (ALS) of SAFRAN RTM 322-01/9 Engine Base Maintenance Manual (EBMM) M3-A-EBM-00-D and the ALS of SAFRAN RTM 322-01/9A EBMM M3-B-EBM-00-D, both approved on 24 February 2023.



**The AMP:** The Aircraft Maintenance Programme (AMP) contains the tasks on the basis of which the scheduled maintenance is conducted to ensure the continuing airworthiness of each operated engine. For RTM 322-01/9 and RTM 322-01/9A engines installed on helicopters operated under EU regulations, the operator or the owner ensures compliance with the AMP as stipulated in Commission Regulation (EU) [1321/2014](#).

**New and/or more restrictive tasks and limitations:** This includes all tasks and limitations that are new and all tasks and limitations for which a threshold or interval was reduced, which were introduced into the ALS (as defined in this AD) since the previous ALS revision that is currently incorporated in the AMP.

#### Reason:

The airworthiness limitations and/or certification maintenance instructions for RTM 322-01/9 and RTM 322-01/9A engines, which are approved by EASA, are currently defined and published in the SAFRAN RTM 322-01/9 EBMM, reference M3-A-EBM-00-D and in the SAFRAN RTM 322-01/9A EBMM, reference M3-B-EBM-00-D. These instructions have been identified as mandatory for continued airworthiness.

Failure to accomplish these instructions could result in an unsafe condition.

Previously, EASA issued AD 2017-0235, AD 2022-0254 and AD 2022-0255 to require implementation of the airworthiness limitations as specified in SAFRAN RTM322-01/9 EBMM M3-A-EBM-00-D dated 30 September 2017, and in SAFRAN RTM 322 01/9A EBMM M3-B-EBM-00-D and RTM 322 01/9 EBMM M3-A-EBM-00-D dated 30 October 2022.

Since those ADs were issued, SAFRAN published the ALS containing new and more restrictive tasks and limitations.

For the reason described above, this AD retains the requirements of EASA AD 2017-0235, AD 2022-0254 and AD 2022-0255, which are superseded, and requires accomplishment of the actions specified in the ALS.

#### Required Action(s) and Compliance Time(s):

Required as indicated by this AD, unless the actions required by this AD have been already accomplished:

#### Maintenance Tasks and Replacement of Life Limited Parts:

- (1) From the effective date of this AD, accomplish the following actions, as specified in the ALS, as applicable, depending on engine configuration:
  - (1.1) Remove each component before exceeding the applicable life limit; and
  - (1.2) Within the thresholds and intervals, accomplish all applicable maintenance tasks.

#### Corrective Action(s):

- (2) In case of finding discrepancies (as defined in the ALS) during accomplishment of any task as required by paragraph (1) of this AD, within the compliance time specified in the ALS,



accomplish the applicable corrective action(s) in accordance with the applicable SAFRAN maintenance documentation. If no compliance time is identified in the ALS, accomplish the applicable corrective action(s) before next flight. If a detected discrepancy is not identified in the ALS, before next flight, contact SAFRAN for approved instructions and accomplish those instructions accordingly.

#### **AMP Revision:**

- (3) Within 12 months after the effective date of this AD, revise the approved AMP by incorporating the limitations, tasks and associated thresholds and intervals described in the ALS, as applicable, depending on engine configuration.

#### **Credit:**

- (4) If, before the effective date of this AD, the AMP has been revised to incorporate the maintenance tasks and life limitations as specified in a previous ALS revision, that action ensures the continued accomplishment of those tasks and limitations.

Consequently, for a helicopter to which that AMP applies, it is acceptable to accomplish the new and/or more restrictive tasks and limitations as specified in the ALS, as applicable, depending on engine configuration, within the compliance times as specified in the ALS to comply with paragraph (1) of this AD.

For that AMP, it is acceptable to incorporate the new and/or more restrictive tasks and limitations as specified in the ALS, as applicable, depending on engine configuration, into the AMP to comply with paragraph (3) of this AD.

#### **Recording AD Compliance:**

- (5) When the AMP of a helicopter has been revised as required by paragraph (3) or (4) of this AD, as applicable, that action ensures continued accomplishment of the tasks as required by paragraphs (1) and (2) of this AD for the engine(s) installed on that helicopter. Consequently, after revising the AMP, as required by paragraph (3) or (4) of this AD, as applicable, it is not necessary that accomplishment of individual action is recorded for demonstration of AD compliance on a continued basis.

The use of later approved revisions of the above-mentioned documents is acceptable for compliance with the requirements of this AD.

#### **Remarks:**

1. If requested and appropriately substantiated, EASA can approve Alternative Methods of Compliance for this AD.
2. This AD was posted on 11 December 2023 as PAD 23-140 for consultation until 08 January 2024. No comments were received during the consultation period.
