

Notification of a Proposal to issue an Airworthiness Directive

Note: This Proposed Airworthiness Directive (PAD) is issued by EASA, acting in accordance with Regulation (EU) 2018/1139 on behalf of the European Union, its Member States and of the European third countries that participate in the activities of EASA under Article 129 of that Regulation.

In accordance with the EASA Continuing Airworthiness Procedures, the Executive Director is proposing the issuance of an EASA Airworthiness Directive (AD), applicable to the aeronautical product(s) identified below.

Falcon 7X aeroplanes, all manufacturer serial numbers (s/n);

Mystère-Falcon 900 and Falcon 900EX aeroplanes, all s/n; and

Falcon 2000 and Falcon 2000EX aeroplanes, all s/n.

Definitions:

For the purpose of this AD, the following definitions apply:

The SB: Dassault Service Bulletin (SB) SB 7X-556 Revision (Rev.) 1 and SB F2000EX-497 Rev. 1, as applicable.

Vendor SB: B/E Aerospace SB SB-3ABF0107-25-20 and Collins SB SB-3ABF0207-25-15, as applicable.



Affected seat: Any single seat assembly and any double seat assembly, having a Part Number (P/N) and a s/n listed in Table 1 or Table 2 of Appendix 1 of this AD, except those which have been modified in accordance with the instructions of the Vendor SB.

Serviceable seat: Any single seat assembly P/N 3ABF0107() and double seat assembly P/N 3ABF0207(), which is not affected parts (see Note 1 of this AD).

Note 1: () represents any alpha/numerical sequence.

Groups: Group 1 aeroplanes are those that have an affected seat installed. Group 2 aeroplanes are those that do not have an affected seat installed.

Reason:

Occurrences of affected seats sliding without passenger input were reported.

This condition, if not corrected, could lead to failure of the affected seat to remain in its position during critical phases of flight, possibly resulting in injury to passengers.

To address this potential unsafe condition, Dassault issued the SB, including reference to the Vendor SB, to provide the list of affected seats and instructions to modify those affected seats.

For the reasons described above, this AD requires modification of affected seats and prohibits their (re)installation.

Based on available information, no affected seats are known to have been installed on Mystère-Falcon 900, Falcon 900EX and Falcon 2000 aeroplanes, and Dassault published no SBs for those aeroplanes. Since the affected seats are eligible for installation on those aeroplanes, this AD prohibits installation of affected seats on those aeroplanes.

Required Action(s) and Compliance Time(s):

Required as indicated by this AD, unless the action(s) required by this AD have been already accomplished:

Modification/Replacement:

- (1) For Group 1 aeroplanes: Within 13 months after the effective date of this AD, modify each affected seat in accordance with the instructions of the SB.
- (2) Replacing an affected seat of an aeroplane with a serviceable seat is an acceptable method to comply with the modification requirement of paragraph (1) of this AD for that aeroplane. The applicable Aircraft Maintenance Manual provides acceptable instructions to accomplish the replacement.

Part(s) Installation:

(3) Do not install an affected seat on any aeroplane, as required by paragraph (2.1) or (2.2) of this AD, as applicable (see Note 2 of this AD):



- (3.1) For Group 1 aeroplanes: After modification of the aeroplane as required by paragraph (1) of this AD.
- (3.2) For Group 2 aeroplanes: From the effective date of this AD.

Note 2: Removing an affected seat from an aeroplane and, during the same maintenance visit, re-installing that seat on the same location of the same aeroplane, is not considered "install" as specified in paragraph (3) of this AD.
