Note: This Proposed Airworthiness Directive (PAD) is issued by EASA, acting in accordance with Regulation (EU) 2018/1139 on behalf of the European Union, its Member States and of the European third countries that participate in the activities of EASA under Article 129 of that Regulation.

In accordance with the EASA Continuing Airworthiness Procedures, the Executive Director is proposing the issuance of an EASA Airworthiness Directive (AD), applicable to the aeronautical product(s) identified below.

## ATA 05 – Time Limits / Maintenance Checks – Airworthiness Limitations Section – Amendment

#### Manufacturer(s):

Leonardo S.p.A. Helicopters, formerly Finmeccanica S.p.A, AgustaWestland S.p.A., Agusta S.p.A.; and AgustaWestland Philadelphia Corporation, formerly Agusta Aerospace Corporation

#### **Applicability:**

AB139 and AW139 helicopters, all serial numbers.

#### **Definitions:**

For the purpose of this AD, the following definitions apply:

**The ALS**: Leonardo AB139 and AW139 Maintenance Manual (MM), 39-A-AMPI-00-P, Chapter IV, Airworthiness Limitations, Issue 015.

**The AMP**: The Aircraft Maintenance Programme (AMP) contains the tasks on the basis of which the scheduled maintenance is conducted to ensure the continuing airworthiness of each operated aircraft. For aircraft operated under EU regulations, the operator or the owner ensures compliance with the AMP as stipulated in Commission Regulation (EU) 1321/2014.

**New and/or more restrictive tasks and limitations**: This includes all tasks and limitations that are new and all tasks and limitations for which a threshold or interval was reduced, which were introduced into the ALS, as defined in this AD, since the previous ALS revision that is currently incorporated in the AMP.

#### Reason:

The airworthiness limitations for the AB139 and AW139 helicopters, which are approved by EASA, are currently defined and published in the Leonardo MM, 39-A-AMPI-00-P, Chapter IV, Airworthiness Limitations. These instructions have been identified as mandatory for continued airworthiness.

Failure to accomplish these instructions could result in an unsafe condition.

EASA previously issued AD 2018-0132 to require the actions described in Leonardo MM 39-A-AMPI-00-P Chapter IV, Issue 9.

Since that AD was issued, Leonardo published the ALS, as defined in this AD, which contains new and/or more restrictive tasks and limitations.

For the reason described above, this AD retains the requirements of EASA AD 2018-0132, which is superseded, and requires accomplishment of the actions specified in the ALS.

#### Required Action(s) and Compliance Time(s):

Required as indicated by this AD, unless the action(s) required by this AD have been already accomplished:

#### Maintenance Tasks and Replacement of Life Limited Parts:

- (1) From the effective date of this AD, accomplish the following actions, as specified in the ALS, as applicable to helicopter model and configuration:
  - (1.1) Replace each component before exceeding the applicable life limit, and
  - (1.2) Within the thresholds and intervals, accomplish all applicable maintenance tasks.

#### Corrective Action(s):

(2) In case of finding discrepancies during accomplishment of any task as required by paragraph (1) of this AD, before next flight, accomplish the applicable corrective action(s) in accordance with the applicable Leonardo maintenance documentation. If a detected discrepancy cannot be corrected by using existing Leonardo instructions, before next flight, contact Leonardo for approved instructions and accomplish those instructions accordingly.

#### AMP Revision:

(3) Within 12 months after the effective date of this AD, revise the approved AMP by incorporating the limitations, tasks and associated thresholds and intervals described in the ALS, as applicable to helicopter model and configuration.

#### Credit:

(4) If, before the effective date of this AD, the AMP has been revised to incorporate the maintenance tasks and limitations as specified in a previous revision of the ALS, that action ensures the continued accomplishment of those tasks and limitations.

Consequently, for a helicopter to which that AMP applies, it is acceptable to accomplish the new and/or more restrictive tasks and limitations as specified in the ALS, as applicable to helicopter model and configuration, within the compliance times as specified in the ALS to comply with paragraph (1) of this AD.

For that AMP, it is acceptable to incorporate the new and/or more restrictive tasks and limitations as specified in the ALS, as applicable to helicopter model and configuration, into the AMP to comply with paragraph (3) of this AD.

#### **Recording AD Compliance:**

(5) When the AMP of a helicopter has been revised as required by paragraph (3) or (4) of this AD, as applicable, that action ensures continued accomplishment of the tasks and limitations as required by paragraphs (1) and (2) of this AD for that helicopter. Consequently, after revising the AMP, as required by paragraph (3) or (4) of this AD, as applicable, it is not necessary that accomplishment of individual action is recorded for demonstration of AD compliance on a continued basis.
