Applicability:	These parts a	See list of aircraft parts and equipment in Table 1 of this SIB. These parts are known to be installed on, but not limited to, AgustaWestland A109 helicopters.			
Description:	Ente Nazionale Aviazione Civile (ENAC) Italy informed EASA of several aircraft parts and equipment which were probably lost when they were transferred from one operator to another between November and December 2013. These parts and equipment, listed in Table 1 below, have to be considered unapproved and not eligible for installation on an aircraft.

If any of the above parts or equipment is found on an aircraft or held in stock, the part or equipment should be removed and quarantined to prevent its installation.
