## **AEROSPATIALE SA 330 helicopters**

Main rotor head spindles

The present Airworthiness Directive applies to the main rotor head spindles whose part numbers are listed below and which are fitted on AEROSPATIALE SA 330 helicopters; versions F, G, J.

Classification of the spindles concerned by part numbers :

- 1) 330A31-1122.03 and .06 (whether or not it is followed by the letter R)
- 2) 330A31-1122.07 (whether or not it is followed by the letter R) and .09 330A31-1782.00
- 3) 330A31-1782.02 330A31-1122.08 (whether or not it is followed by the letter R) and .10

Subsequent to the fatigue failure of a spindle, the following measures are rendered mandatory:

- A/ Apply paragraph 1C(1) of SA 330 Service Bulletin N° 01.45 :
  - a) On the spindles referenced in paragraphe 1), 2) and 3) in the event of an oil leak on the feathering hinge, or oil consumption without leakage, or abnormal and progressive evolution in the rotor dynamic balance (Apply the leakage criteria given on MET work card 5.53.201).
  - b) On the spindles referenced in paragraph 2) every 50 operating hours.

- c) On the spindles referenced in paragraph 3) every type P2 inspection.
- B/ The spindles referenced in paragraph 1) were to be removed from service within the next 50 flying hours or the next two months counted from the date of issue of the original telegraphic Airworthiness Directive.
- C/ From the date of receipt of revision 1 of this Airworthiness Directive, all the spindles referenced in paragraphs 2) and 3) must be overhauled every ten years. Spindles which have been in service for more than 9 years since new or since their last overhaul at this date must be overhauled within one year from that date.
