THOMSON low range radio altimeter (LRRA) (ATA 34)

APPLICABILITY:

This Airworthiness Directive applies to all AIRBUS INDUSTRIE A330 A330-301, -321, -322, -341 and -342 aircraft, fitted with THOMSON radio altimeters P/N 9599-607-19501.

<u>Note</u>: The AIRBUS INDUSTRIE A330 aircraft which have received the AIRBUS INDUSTRIE modification 41510 which installs COLLINS (LRRA) are not concerned by the requirements of this Airworthiness Directive.

REASON:

This AD is prompted in order to prevent risks linked to erratic electrical signals causing radio height fluctuations on ground and in-flight caused by presence of moisture in the low range radio altimeter (LRRA) P/N 9599-607-19501.

This Revision 2 reduces the applicability of the AD.

COMPLIANCE:

The following measures are rendered mandatory.

1. MAINTENANCE MEASURES

Accomplish the AIRBUS INDUSTRIE A330/A340 AOT 34-02 dated December 21, 1995, instructions as mentioned under paragraph 4.1 :

- Within 10 calendar days following the effective date of the original issue of this AD, or before any automatic landing whichever occurs first perform the check of the bite codes of each operating radio altimeter (sides 1 and 2).
- Repeat every 7 calendar days before the application of the THOMSON-CNI SIL ERT-540-34-003 Revision 1.

- Every 500 FH after the application of the THOMSON-CNI SIL ERT-540-34-003 Revision 1.
