Override mechanism of trimmable horizontal stabilizer (THSA) - Electrical control

This Airworthiness Directive applies to AIRBUS INDUSTRIE A330 aircraft -301; -321; -322; -341; -342 models which have not received AIRBUS INDUSTRIE modification 45631 (Service Bulletin A330-27-3056).

It order to prevent a failure of a manual override switch in the open position, which, combined with either a THSA control wheel blockage by pilot action or a mechanical control jam (transient jam) may result in an electrical THS runaway, the following measures are rendered mandatory on the effective date of this Airworthiness Directive:

- 1) Not later than 500 flight hours after the effective date of the initial issue of this Airworthiness Directive, accomplish the performance periodical test of the override mechanism of the THSA electrical control to check the correct functioning of the 3 override switches in accordance with the instructions given in the AIRBUS INDUSTRIE Service Bulletin A330-27-3051.
- 2) Repeat the periodic test as defined in paragraph 1) of this Airworthiness Directive:
 - **a)** At intervals not to exceed 500 flight hours in accordance with the instructions given in AIRBUS INDUSTRIE Service Bulletin A330-27-3051.
 - **b)** Every day if the aircraft is performing training flights and then repeat this test every 500 flight hours after the training period is completed.
