ATA 5 - TIME LIMITS - REVISED AIRWORTHINESS LIMITATIONS

Manufacturer(s): British Aerospace plc.

Applicability: All British Aerospace Model ATP aeroplanes.

Reason: The certification requirements for damage tolerant and safe life structure are given in BAe ATP Aircraft Maintenance Manual (AMM) Chapter 5. The need to revise these requirements has been identified. The changes introduced by this AD primarily recognise the introduction of modification JDM60138N that installs an energy-absorbing stop to aircraft fitted with the large freight door. Failure to adopt the latest revision of the AMM chapter 5 could result in structural deterioration remaining undetected that if not corrected could lead to catastrophic structural failure and consequent loss of life. In addition reformatting of the Aircraft Maintenance Manual (AMM) Chapter 5 has taken place to separate Structures items from System items. Some minor editorial changes have also been made to the text of a number of SSIs.

Effective Date: 31 October 2005

Compliance/Action: From the effective date of this AD, compliance with the following parts of Chapter 5 of the Aircraft Maintenance Manual revision 76 or later EASA approved revision are mandated by this AD.
