BIJZONDERE LUCHTWAARDIGHEIDSAANWIJZING (BLA) **NETHERLANDS AIRWORTHINESS DIRECTIVE**

Onder verwijzing naar BLA nr. 68-19-00 en BLA nr. 74-70-00 geeft de directeur Luchtvaartinspectie van de Rijksluchtvaartdienst de volgende Bijzondere Luchtwaardigheidsaanwijzing.

Under authority of the Netherlands Regulations on the State Control of Aviation the Director Aeronautical Inspection of the Civil Aviation Department gives the following Airworthiness Directive.

ELECTRICAL POWER - BUS BARS & CONTACTORS TORQUE VALUES - INSPECTION/ADJUSTMENT

Description:

Recently, an incident occurred on a Fokker 100, involving smoke on the flight deck during approach. The most probable cause is thought to be a not properly tightened terminal on a generator line contactor (GLC) in the electrical power centre (EPC). The contactor's resistance generated enough heat to make the terminal red hot, which resulted in the partial melting of the EPC. As unproperly tightened connections have also been found on other aircraft, this Airworthiness Directive (BLA) calls for the inspection and adjustment of the torque values on the bus bars and contactors in the EPC and on the relay panel in forward cargo compartment.
