1. EFFECTIVITY:

The present Airworthiness Directive (AD) is applicable to the following EADS SOCATA TBM 700 aeroplane with serial numbers, from 1 to 32, 34, 36 to 69, 71 to 76, 79, 81 to 92, 96 to 98, 101, 102, 107 to 109, 112 to 114, 116,118 to 124, 126 to 130, 132 to 135, 137, 138, 140 to 145, 148 to 155, 157, 158, 161 to 268, 270 to 304.

Note: from the rank 305, greasing is factory made.

2. REASONS:

An unsatisfactory initial Elevator trim actuator greasing may lead to the icing of the Elevator trim and generate an untrimmed nose-up attitude after an Auto-Pilot (AP) disconnection.

The previous AD F-2004-190 requested a greasing of the elevator trim actuator.

This new AD:

- Maintains the requested greasing of the AD F-2004-190 but reduces compliance time,
- Mandates Revision 1 of Service Bulletin EADS SOCATA TBM 700 No BS 70-124, dated January 2005,
- Details effectivity.

Consequently, this AD replaces AD F-2004-190 which is cancelled.

3. MANDATORY ACTIONS AND COMPLIANCE TIMES:

The following measures are made mandatory from the effective date of this AD:

Unless previously accomplished, within the next 25 flight hours or on the next scheduled Inspection, whichever occurs first and not to exceed April 15, 2005, perform the greasing of the elevator trim actuator in accordance with the instructions given in the EADS SOCATA Service Bulletin in reference.
