## Subject:

Flight Controls - Vertical airbrake steering tube in the fuselage

### Reason:

The Luftfahrt-Bundesamt has been informed by the manufacturer about cracks on the attachment of the L'Hotellier-head, a broken bracket in the area of the L'Hotellier-head and a lower attachment bracket of the steering-tube broke away from the fuselage.

# **Action/Compliance:**

1) Within the next 10 hours time in service:

Visual check of the attachment for cracks and check of the lower attachment of the steering-tube in the fuselage. If damages were detected: perform a modification in accordance with the Technical publication of the manufacturer (Action 2. and 4. of the Technical Note).

2) Before 31 December 2006, if not already has been done after the checks of Action 1): Perform the Modification in accordance with the Technical publication of the manufacturer (Action 2. and 4. of the Technical Note).

The action must be done in accordance with the Technical publication of the manufacturer.

# Holders of affected aircraft registered in Germany have to observe the following:

Action has to be accomplished by the owner of the aircraft or an approved service station and to be checked and entered in the log book by a licensed inspector.

As a result of the a.m. deficiencies, the airworthiness of the aircraft is affected to such an extent that after the expiry of the a.m. dates the aircraft may be operated only after proper accomplishment of the prescribed actions. In the interest of aviation safety outweighing the interest of the receiver in a postponement of the prescribed actions, the immediate compliance with this AD is to be directed.

An appeal to this notice may be raised within a period of one month following notification. Appeals are to be raised with the Luftfahrt-Bundesamt, Hermann-Blenk-Str. 26, 38108 Braunschweig, in writing or for the purpose of drawing up minutes.
