Reason: It has been discovered that a batch of sleeves and pins of the Rolls-Royce Trent 700 Thrust Reverser Unit (TRU) hinge n°5 has not been subjected to the correct precipitation hardening. This production quality issue, if not corrected, can lead to the complete failure of the hinge n°5 – the remaining hinges may not sustain ultimate load - resulting in the worst case to the TRU release from the pylon, which constitutes an unsafe condition. The degradation of the mechanical specifications of these parts puts into

question the current design life goal of these parts. Consequently, the
