It is possible that the fixation bracket assembly may be incorrectly orientated and as a result the position of the helicoil inserts on the fixation bracket may be incorrect.	
	If the orientation of the fixation bracket is reversed or upside down the screw may not reach into the helicoil thread to a sufficient depth.	
	An incorrect installation, if not detected and corrected, could lead to an in-fligl failure of the fixation brackets for rudder spring tabs and trim tabs resulting in and reduced control of the aeroplane.	
	To address this potential unsafe condition, the TC holder has developed a on time inspection to detect and correct any incorrect installations of the fixation brackets for rudder spring tabs and trim tabs.
