	(2) If, during any task as required by paragraph (1) of this AD, unusual play and/or wear is detected, before next flight, accomplish a detailed inspection for condition, damage and play in accordance with the instructions of AgustaWestland BT 139-368.	
	(3) If, during any detailed inspection as required by paragraph (2) of this AD, a play beyond the limits or wear is detected, before next flight, replace each affected lower half scissor spherical bearing with a serviceable part and re-identify the S/N of the M/R Rotating Scissors P/N 3G6230A00733 in accordance with the instructions of AgustaWestland BT 139-368.	
	Note 1: For the purpose of this AD, a serviceable lower half scissor spherical bearing P/N 3G6230V00654 is a part that has a S/N not listed in Table 2 of AgustaWestland BT 139-368.	
	(4) Unless already accomplished as required by paragraph (3) of this AD, within 50 FH or 30 days, whichever occurs first after the effective date of this AD, replace each affected lower half scissor spherical bearing with a serviceable part and re-identify the S/N of the M/R Rotating Scissors P/N 3G6230A00733 in accordance with the instructions of AgustaWestland BT 139-368.	
	(5) As an alternative to actions as required by paragraph (3) or (4) of this AD, it is allowed to replace the M/R Rotating Scissor P/N 3G6230A00733 with a serviceable part.	
	Note 2 For the purpose of this AD, a serviceable M/R Rotating Scissor P/N 3G6230A00733 is a part having a S/N not listed in Table 1 of AgustaWestland BT 139-368, or a part on which no lower half scissor spherical bearing P/N 3G6230V00654 with S/N listed in Table 2 of AgustaWestland BT 139-368 is installed, or a part which has been corrected and re-identified in accordance with the instructions of AgustaWestland BT 139-368.	
	(5) Replacement of affected parts on a helicopter as required by paragraph (3) or (4) of this AD constitutes terminating action for the repetitive inspections as required by paragraph (1) of this AD for that helicopter.

	(6) From the effective date of this AD, installation on a helicopter of M/R Rotating Scissor P/N 3G6230A00733 or lower half scissor spherical bearing P/N 3G6230V00654 is allowed, provided it is a serviceable part as defined in this AD.
